- Submit 2-3 vertical professional high-resolution (at least 300 dpi) DIGITAL photographs of the bride and groom on CD, non-returnable. One photo will be chosen by *Delta Magazine* editors.
- Include payment in the form of a check made payable to *Delta Magazine*. We also accept all major credit cards (see below). Space will not be reserved until payment is received.
